## FIRST FLOOR, MENSWEAR. SECOND FLOOR, DISASTER.

A Detroit, MI, department store installed 2,500 square yards of carpet and expected to get at least 8 years out of it. After less than two years, spots and stains could not be removed. It turns out the cause was an inadequate cleaning and maintenance program. And the only solution was a total carpet liquidation.

## MAKING CARPET FEEL VERY UNWELCOME.

Condominiums in Boca Raton, FL, put down 1,800 square yards of custom-patterned carpet. Life expectancy was 6-8 years. In less than 12 months, it had gone ugly and soiled. The problem was the wrong products were used to maintain the carpet. In the end it had to be pulled up and replaced.
